BATON ROUGE, LA — July 2, 2020 — City-Parish offices will be closed on Friday, July 3rd in observance of the Independence Day holiday. However, government facilities that are polling places, including City Hall, will be open for early voting for the July 11 election on Friday-Saturday, July 3-4.

Residential garbage (both in cart and out of cart woody waste/bulky items) and recycling will be collected as normal on Friday, July 3rd and on Saturday, July 4th. Additionally, the landfill will be open normal business hours on Friday, from 5:30 am – 5:00 pm and on Saturday, from 7:00 am – 3:00 pm.

Spike in Younger Coronavirus Cases Creates Testing Dilemma



BATON ROUGE, La. - As young Louisianans continue to drive the spike in COVID-19 cases, state health leaders are faced with a dilemma: prioritize testing for apparently-healthy people who might be silent carriers, or for sick people who need to seek treatment.

Roughly 20% of the Louisianans who've tested positive for COVID-19 are between ages 18 and 29. Though health experts are not certain, it appears younger people are more likely to unknowingly spread the virus because they don't demonstrate severe symptoms as often.

"There's still not as much testing as we would like, so you still have to have priorities," Gov. John Bel Edwards said during his Coronavirus briefing Wednesday, July 1. "It's really hard to not prioritize symptomatic individuals who are more likely to have it and need to know if they have it."

Edwards says it is becoming more important to test asymptomatic people, which is why the state is ramping up testing in certain regions. Four new sites in Baton Rouge could open as soon

Joyful Juneteenth Marchers

in D.C. Confound Predictions of Violence Black Lives Matter

Protesters swarmed D.C. streets—not demanding to be heard, but dancing for joy that everyone is listening.

After weeks of media coverage about rioters and looters who hijacked protests following George Floyd's death, Washington D.C. held its breath as Juneteenth marches wound up their springs on Friday. No one needed to worry. It was festive, not angry. People sold T-shirts. One woman led hundreds down Pennsylvania Avenue while belting Beyoncé's "Freedom" anthem at the top of her lungs through a bullhorn.

This was a victory parade. Black Lives Matter activists have made their point and won

"The "No Mask, No Service" policy will help ensure our businesses can remain open and safely serve customers. My message to our community is simple:

School Board Favors Hearing Bew Names for Lee High School

BATON ROUGE, La. - The East Baton Rouge Parish School Board on Thursday, June 18 unanimously agreed to hear recommendations for a new name for Lee High School.

The school's name again became the center of controversy as black American residents in the parish, in addition to other communities of color and organizations, questioned the purpose of continuing to "recognize" and "memorialize" the legacy of confederate commander Robert Edward Lee in a way typically associated with being an "honor."

Lee's legacy attracts scrutiny be-

EBR School Board President Calls for Connie Bernard's Resignation

BATON ROUGE, La. - East Baton Rouge Parish School Board President Michael Gaudet released a statement Thursday calling for the resignation of embattled board member Connie Bernard.

"On June 22, 2020 I issued a statement that voiced my disapproval of Mrs. Bernard's actions during the recent School Board meeting but stopped short of calling for her to resign. Information has now come to light which shows her public statement on the issue was, in my opinion, misleading. I believe this erodes her ability to retain the confidence of the public that we serve. We work diligently to improve public education in East Baton Rouge and without public confidence, our job is more difficult. Most critically the children, with whose education we are entrusted, will suffer the greatest in the long run. I now respectfully ask Mrs. Bernard to resign her office as a member of the EBR School Board.

I do not make this request lightly. I know that Mrs. Bernard takes her responsibilities to represent all children seriously. She is an elected official and her voters need a voice.

I will take no position on the current effort to recall Mrs. Bernard. I respect the wisdom and authority of the voters in her district to make that decision. It is their decision to make and theirs alone.

As members of the EBR School Board we are called first to remember what we were elected to accomplish. We must focus on educational issues impacting our children now. Reopening schools amid the Covid-19 pandemic, many low performing schools, on-boarding a new Superintendent, unifying our

community, budget inequities and funding shortages are just a few of the challenges facing us. These should be our focus, now and in the future. I am hopeful that the EBR School Board, helped by the leadership of our new Superintendent, will put differences aside and work together to improve the opportunities for all our children.'

Bernard first came under fire two weeks ago when she was called out for online shopping during a passionate debate to strip confederate general Robert E. Lee's name from the high school.

"And you sit your arrogant self in here and sit on there shopping because you don't give a damn and you should resign," community activist, Gary Chambers, said during the meeting.

When Bernard faced allegations that she was shopping, she denied it, saying the picture that was making the rounds was actually a pop-up ad that she failed to close, but a further and more thorough review of those records by the 9News Investigators turned

up even more shopping.

Several of her colleagues and people around the nation have called for Bernard's resignation. A statement released by Bernard on June 22 said she "will continue to serve all students as elected by my district three times."

millions of converts since May25. Fortune 500 companies and major league sports are on board. Celebrities everywhere have become force multipliers. In some cities, police officers knelt in common cause with groups of activists.

And here they were on Juneteenth, blocks from America's epicenter of power. Not demanding to be heard, but dancing for joy that everyone, everywhere, was finally listening and that African Americans were writing a new chapter in a never-ending story.

More than a dozen demonstrations had more than a dozen messages - "Defund the Police" and "Defend Black Women" were two-but the violent subculture seemed to stay home, and seemed to know this wasn't their moment.

No one was looting or setting fires. The only glow came from mostly black faces with ear-toear grins that peeked out when COVID-19 masks came off.

Yes, we saw performan art. A Latino portrayed a crucified Jesus, complete with a giant wooden cross, and a cloth across his hips with the letters B-L-M painted in slapdash foam-brush

And the sounds! Social justice chanting competed for our ears with the occasional drummer and a trombone player, blasting his brass in front of the Trump International Hotel.

racist police." Some women held simple signs, each with the name of a black woman or girl killed by law enforcement. Nunruh Laroche. Della McDuffie. Deeniquia Dodds. 100 in all.

"No Justice, no peace, no

The signs were simple, just the names in black letters, floating on a white background.

One little girl tried to whip up her own chanting section. "Black kids, we are so cool!" she shouted. "So get the cops out of our school!"

curately claims that the property was donated by the Buffwood Community. In fact, the Landry and Nettles family heirs donated this property to the City of Baker in March 2014; the Buffwood Community was not involved nor was a nonprofit the recipient. This donation to the City of Baker was

approved by the City Council of Baker on November 12, 2013 In paragraph two, she inaccurately claims there are plans to turn this property into a "community center". There are no formal plans nor has there been significant discussion thus far as to what ultimately the property will be used for.

In paragraph three, the City of Baker received a Louisiana Local Government Assistances (LGAP) Grant from the State of Louisiana to make necessary renovations so the building maintains its ability to meet code standards. A grant recently applied for and obtained states that its future use would be for "city approved meetings". Grant funds were obtained because this city property ideally could be used for city approved meetings such as Rotary Club, Pilot Club, or other civic organizations with approval from the city. This, however, is only in preliminary discussion stages with no final decisions having been made.

It is important to remember because this building is owned by the City of Baker, the city is responsible, just as any homeowner or business owner is responsible for the maintenance and upkeep of their buildings as required by City of Baker Code Enforcement policies.

In paragraph five of the letter, public comment for routine maintenance of a city owned building is not necessary nor required.

Ultimately, it appeared that this letter served no purpose other than to try to create political controversy where none exists. Ms. Alexander was and is fully aware of the true facts when she authored this letter which I explained and emphasized to her clearly during the City Council meeting on May 12, 2020.

As a City Council Member, she should be aware that the Council and the City of Baker would be remiss in their duty to fail to make the needed repairs to a building which the city owns and which is located in her neighborhood which she professes

as Tuesday, including drive-thrus at LSU and Southern University.

"We like to get people across the age spectrum, and those are two pretty big sites to (get young people)," the Louisiana Department of Health's Dr. Joseph Kanter said.

LDH has already identified outbreaks connected to 19 different bars across the state, including at Tigerland, a popular student watering hole near LSU's campus.

"Folks really should be seated at tables, even at bars," Kanter said. "If you've been in a setting where that wasn't happening and people were within 6 feet of each other, I think you should consider yourself exposed and look for testing options in your region."

Louisiana is a global leader in testing per capita, but materials are still limited. Long lines are forming at testing sites and the turnaround time for results from certain vendors is "unacceptable," Kanter said.

The state is relying on the federal government and private testers to provide more kits so the state does not have to choose between healthy or sick people.

BRCC to eliminate non-resident fees, suspend online fees this fall, and offer several institutional aid awards

BATON ROUGE, LA-As the state continues to deal with the growing COVID-19 threat and the uncertainty regarding future timelines, Baton Rouge Community College is introducing special changes that will allow the college to continue offering the same great educational and support opportunities for students during the Fall 2020 semester. BRCC is eliminating non-resident fees and suspending online fees for students this fall. A bevy of institutional aid awards are also available, and there is no application fee for new students to enroll. The elimination of non-resident fees will save full-time students more than \$2000 and full-time online non-resident students approximately \$2500. This means out-of-state students will be charged approximately half of the cost over last year.

"We are aware that many members of our community will need BRCC more than ever after dealing with the repercussions from COVID-19," said BRCC Chancellor Dr. Willie E. Smith. "We hope that by eliminating some of the financial burden, we can be a key partner in assisting people with getting the necessary training and credentials to begin their careers or continue their studies. As an accredited institution of higher learning, this incredible offer allows students to take courses here at BRCC that are transferrable to their home institution."

BRCC is also introducing special changes that will allow the college to continue offering the same great educational and support opportunities for students. BRCC will offer general education courses through online synchronous (live instruction) and asynchronous (attend on your schedule) classes, while Technical Education and Nursing and Allied Health classes, along with some labs, will be offered through a hybrid design, where students will complete some coursework online and attend some face-to-face classes on campus in a sanitized environment, while practicing social distancing and wearing masks. The college will continue to offer support for students with technology needs, and student services will remain online through the Virtual Student

cause he owned slaves and fought on battlefields and in courts to continue the enslavement of black Americans, historical records suggest.

The Southern Poverty Law Center published data suggesting dozens of public schools around the nation bear Lee's name. Statues in several American cities were also erected to memorialize Lee.

Both have come under scrutiny as the country reaches a flash-point in discussions on race.

The vote Thursday will allow the school board to form a committee which will hold public meetings to develop a list of names.

That committee will recommend the top choices to the board.

Greater Baton Rouge Jewish Community Open Letter to Our Black Neighbors

Our shared history holds within it, moments of powerful partnership between our communities, and it also holds moments of estrangement and points of pain. We have not forgotten the abhorrent killing of Alton Sterling in our beloved city four years ago, and we continue to mourn his loss.

Specifically, we commit to:

- --seek a deeper understanding of our history and how generations of Black trauma directly relate to the struggles of the present day. We will attempt to fully understand the discrepancy between who we say we are as a nation and who we truly are as regards civil and human rights.
- --be more courageous in our efforts to prevent and respond to future acts of racial and other discrimination emanating from any source. We will condemn race-based hate and bigotry against Black and Brown members of our society whenever and wherever we see it, even and especially when we find it within our own community.
- --support meaningful public policy that addresses the myriad of issues that plague minority communities, including the wide healthcare and economic disparities that have become so apparent during the COVID-19 pandemic. We will advocate in particular for much needed policing reform measures and will seek to be strong coalition partners in the public sphere.







The release of AYO, along with our CBD products, will enable us to help patients better manage their medical issues and improve their quality of life."

tincture developed by Southern and Ilera. ALAFIA launched on January 25 in the Louisiana market, making Southern University the first HBCU producer in both cannabis and hemp. ALAFIA will be available online nationwide later this summer.

"With the launch of both CBD and THC medical marijuana products, Southern continues to set precedents in innovation," said Ray L. Belton, president of the Southern University System. "In addition to providing healthcare options for Louisiana residents, our valued partner, Ilera, is able to hire local talent. All of this impacts our state's economy directly while expanding the Southern University brand."

Southern's medical marijuana program is part of the Ag Center's Southern Institute for Medicinal Plants, helmed by Janana Snowden, the institute's director and an assistant professor of agriculture at Southern University Baton Rouge.

The institute and Ag Center have long researched plants such as hibiscus in addition to cannabis.

"The very important research we conduct on medicinal plants helps us to address health problems that affect communities," Snowden said. "Our products derived from medicinal plants offer patients another way to alleviate symptoms. We are proud that we can be part of many potential solutions."

AYO has been launched at a time that Louisiana has expanded laws to potentially allow more patients to choose medical marijuana for treatment. On June 11, Gov. John Bel Edwards signed into law ACT No 286, allowing any state-licensed physician to recommend medical marijuana to any of their patients to find relief for any condition.

"ACT No 286 makes clear that Louisiana residents want full access to medical cannabis and the right to discuss alternative healthcare options with their doctors," said Chanda Macias, chief executive officer for Ilera Holistic Healthcare. "We are grateful to the entire state legislature in welcoming our input throughout the long history of this bill and listening to the voices of our patients, advocates, doctors and industry colleagues. We had one common goal, which was to bring greater access to medicine for all patients in our great state."

MOVEBR Program On Track To Exceed Local Small Business Participation Target

BATON ROUGE, La. — Hoping to achieve at least 20% in small business participation in the MOVEBR program, Mayor-President Sharon Weston Broome announced the program is on track to exceed that number with current spending committed for preconstruction services at 40% for small businesses and a forecast of at least 33% over the life of the program, excluding program management services.

"By exceeding the target we set for ourselves, the MOVEBR program is helping to keep East Baton Rouge Parish strong."



The Bayou Classic consists of Grambling and Southern Universities locking up every year. Other than the game, fans also look forward to the performances from both University bands.

NEW ORLEANS - The Southwestern Athletics Conference Council of Presidents and Chancellors will have a meeting in late June about 2020 Fall sports.

In the scheduled meeting officials will talk about which will host the 2020 and 2021 Bayou Classics.

Southern University Athletic Director, Roman Banks, gave a conflicting statement Saturday morning saying that the 2020 Bayou Classic will not be played in New Orleans this year, and possibly will not be played in 2021.

Banks did not give specifics as to why the city might not host the annual game but COVID-19 has forced many conventions, events, and sports slated for the fall to be cancelled.

Bayou Classic Committee and Management Company gave a statement via email regarding the statement Banks made:

There has been no decision about the Bayou Classic and any such statements about where the Bayou Classic might be played are premature. The Southwestern Athletics Conference Council of Presidents and Chancellors have a late June meeting where

matters related to Fall sports will be discussed.

The Bayou Classic is an annual football game of the Southwest Athletic Conference (SWAC) between Grambling University and the Southern Jaguars. The game as it is known today was first played in Tulane Stadium in New Orleans although the series itself started in 1932.

As of now, no announcement has been made as to where the game will be played but Banks mentioned Tiger Stadium and Independence Stadium as possibilities.
