

Louisiana latest state to report case of omicron variant



The Louisiana Department of Health reported the state's first omicron COVID-19 variant case on Sunday, The Associated Press reported.

The health agency said the unidentified person who tested positive lives in New

Orleans and has traveled within the U.S.

In a statement, Health Officer Joe Kanter said the state has been preparing for omicron's arrival, according to the AP.

"We now know omicron is here in Louisiana. This is cause for concern, but not panic," Kanter said. "We have been expecting and preparing for this moment. To all Louisianans, the single best action you can take to protect yourselves and your families is to get yourself and loved ones vaccinated and boosted if eligible."

Minnesota, Maryland, Hawaii, New York, California and Colorado have also reported cases of the omicron variant in the past week.

After South Africa first detected omicron cases within its borders, a number of countries, including the U.S., placed travel bans on countries in southern Africa.

On Monday, Southern in a social media post announced that Eric Dooley has been hired as the football program's next head coach.

He replaces Jason Rollins, who was named interim coach for the 2021 fall season after Dawson Odums took the Norfolk State job following the shortened spring campaign.

Rollins, in his lone season at the helm, led Southern to a 4-7 record, including a loss to Grambling State in the Bayou Classic. Dooley, who spent four years at Prairie View, was an assistant at Southern under legendary coach Pete Richardson from 1997-2009. The New Orleans native and long-time assistant made stops as a coordinator at Arkansas-Pine Bluff and Grambling before he landed



Baton Rouge Area Chamber predicts local economy is on its way to full recovery

BATON ROUGE - 'Now Hiring' signs are plastered across the capital city, and help isn't just wanted—it's needed.

"We still have a need for waiters, kitchen help, and pretty much everything that we hire we could use more help," Brad Zito, owner of Drusilla Seafood Restaurant, said.

Like many others, Zito says he finds himself in a tough and tiring situation. He can't find enough staff to serve his customers.

"We have to be careful that we don't take too much business inside the restaurant or inside the catering facility just because we don't have the staff to cover it," he said.

But, that could soon change. According to the Baton Rouge Area Chamber, the Capital Region is well on its way to full economic recovery.

"We lost about 30,000 jobs between 2019 and 2020 in the heart of the pandemic. Since then, we made it halfway back," Andrew Fitzgerald, BRAC's Senior Vice President of Business Intelligence,

Lawmakers reject coronavirus vaccine mandate for Louisiana students

BATON ROUGE, La. — A bipartisan group of Louisiana law-makers Monday voted against Gov. John Bel Edwards' coronavirus vaccine requirement for some students, but the Democratic governor intends to overrule the rejection and add the shot to the immunization schedule starting next school year.

The fate of the plan seems likely to be decided by the courts, with Republican Attorney General Jeff Landry and the Edwards administration at odds over whether the vaccine requirement can be legally enacted by the governor without support from the full Legislature.

The House Health and Welfare Committee objected to the requirement in a 13-2 decision. All GOP lawmakers voted in opposition along with an independent and three Democrats. Only Democratic Reps. Dustin Miller of Opleousas and Robby Carter of St. Helena Parish supported adding the COVID-19 vaccine to the state's immunization schedule for schools.

The Edwards administration said the vote can't legally stop the governor from enacting the regulation.

Edwards "supports adding the safe and effective COVID-19 vaccine to the immunization schedule and, barring a recommendation from public health experts, his opinion would not change," the governor's spokesperson Christina Stephens said in a statement.

Even if the shots are mandated for Louisiana schools, the state allows broad exemptions for parents and students to opt out by submitting a written objection from a doctor or a general written dissent.

Across a daylong hearing, opponents of the regulation described the vaccine requirement as government overreach.

Some downplayed the threat of COVID-19 to children and repeated misinformation suggesting



widespread risks from the vaccine. Others said while they believe in vaccines, they thought it was too soon to require the coronavirus immunization until there was more long-term study. Some said natural immunity from contracting COVID-19 was enough to keep from needing a vaccine, even though infectious disease experts disagree.

"I'm not anti-vaccine. I'm antivaccine mandate," said Rep. Richard Nelson, a Mandeville Republican. "Is this really about controlling the virus anymore, or is this about controlling the citizens?"

Lawmakers worried children could be excluded from in-person classes if they file the exemption paperwork, even though the Louisiana Department of Health said it doesn't intend to push the exclusion of un-

vaccinated children from school. The lawmakers — several of whom said they are vaccinated — said parents should get to make decisions about the shots their children receive.

"Parents should not be forced to jump through hoops," said House Speaker Clay Schexnayder, a Gonzales Republican. He said he doesn't believe the Edwards administration has the authority to add the coronavirus vaccine to the schedule of immunizations required to attend school.

Miller said parents will get the choice they want.
"I think we're simply allowing

"I think we're simply allowing parents to sign paperwork" if they don't want to comply, he said.

Edwards' chief public health adviser, Dr. Joe Kanter, pushed back against suggestions that COVID-19 isn't a significant threat to children, that the vaccines are experimental and that they shouldn't be added to the immunization schedule because they don't keep someone from getting infected.

"Vaccines are the single best tool we have to fight back," he said. "We need to encourage and promote their use while continuing to respect the tradition of parental autonomy which has served us well in Louisiana to date."

Students in Louisiana are required to be immunized against

BRCC Releases Study Detailing Regional Economic Impact of \$300 Million

Students Earn \$5.30 for Every \$1 Invested in BRCC

BATON ROUGE, LA - An economic impact study released today by Baton Rouge Community College reveals the college has a \$300 million impact, or supports 4,520 jobs, annually in the greater Baton Rouge area. The study also found high returns on investment in BRCC, highlighting its value beyond a traditional educational institution as a regional workforcedevelopment and economic pow-

For every dollar they invest in BRCC, students gain \$5.30 in future earnings, according to the study based on 2018-2019 fiscal year data. Taxpayers, meanwhile, gain \$5.60 over the course of students' working lives for every public dollar invested in BRCC.

"These findings solidify what we already know to be true: Baton Rouge Community College is an essential asset to our community in terms of educational success, workforce development and economic growth," Chancellor Willie Smith said. "BRCC offers affordable, high-quality programs that yield dividends for our students, who go on to fill well-paying jobs for essential businesses in our area, representing a win-win for our economy and our graduates. We are incredibly proud to share the results of this study and continue to build on our economic impact going forward."

The study also found that BRCC associate degree graduates earn an average of \$11,400 more in annual income than people with a high school degree or equivalent.

BRCC's \$300 million annual economic impact is a result of \$42.5 million in operational spending, \$18 million in student spending and \$237 million in added alumni income during the 2018-2019 fiscal year, according to the study conducted by Emsi, a labor market analytics firm.

"Baton Rouge Community College continues to positively impact the greater Baton Rouge area in multiple ways," said East Baton Rouge Parish Mayor-President Sharon Weston Broome. "In addition to providing students with the opportunity to upskill and reskill, BRCC is a vital contributor to our community's trajectory of strategic growth, leading to a more prosperous economy and brighter future."

Currently, that's high school students 16 and older. But that would broaden to cover younger children if the FDA grants full backing to the shots for more age groups.

Have you ever been in a situation that suddenly imploded on itself and fell apart without warning? Life is unpredictable sometimes, and things can be great one minute and scary the next. If we rely solely on ourselves to accomplish our goals without any guidance from a higher power, we won't get very far without running into real trouble. Thankfully for us, this "higher power" isn't just some fuzzy concept, but a God who knows exactly what we go through every day of our lives.

When everything goes terribly wrong with no advance warning, we don't have to struggle with it on our own. We have someone in our corner who is God in human form; He's always interceding on our behalf. "Now that we know what we have—Jesus, this great High Priest with ready access to God-let's not let it slip through our fingers. We don't have a priest who is out of touch with our reality. He's been through weakness and testing, experienced it allall but the sin. So let's walk right up to him and get what he is so ready to give. Take the mercy, accept the help" (Hebrews 4:14-16, MSG). The situation may look hopeless, but looks can be deceiving. When Peter saw Jesus walking on water and trusted Him enough to get out of the boat and do the same, he gained the ability to do what looked impossible. That ability came from God, but when Peter became afraid, stopped trusting Jesus, and fell, Jesus still rescued him.

And when the disciples saw him walking on the sea, they were troubled, saying, it is a spirit; and they cried out for fear. But straightway Jesus spake unto them, saying, be of good cheer; it is I; be not afraid. And Peter answered him and said, Lord, if it be thou, bid me come unto thee on the water. And he said, come. And when Peter was come down out of the ship, he walked on the water, to go to Jesus. But when he saw the

wind boisterous, he was afraid; and beginning to sink, he cried, saying, Lord, save me. And immediately Jesus stretched forth his hand, and caught him, and said unto him, O thou of little faith, wherefore didst thou doubt? (Matthew 14:26-31).

When the storms of life threaten to drown us—and they will threaten—it takes courage to seek out God's direction on what to do. 
